

GodzyCasting Terms and Conditions

1. Introduction

These Terms and Conditions (the "Agreement") constitute a legally binding agreement between [Your Name], hereinafter referred to as "TALENT," and GodzyCasting, a division of Godzy Media Consult, having its office at Madina Estate, Accra, Ghana, hereinafter referred to as the "MANAGER" or "AGENT."

2. Representation Agreement

2.1 Exclusive Representation

TALENT hereby engages the MANAGER as either the exclusive or non-exclusive (as specified) representative for the purposes of pursuing opportunities in modeling, show business, and any other creative field, including new media (hereinafter collectively referred to as "Exploitation").

2.2 Conflicting Contracts

TALENT warrants that they are not presently under any other contracts that may conflict with this Agreement.

3. Role of the MANAGER

3.1 Business Advisor and Negotiator

The MANAGER will serve as a business advisor and negotiator on behalf of TALENT regarding employment contracts and agreements entered into by TALENT during the term of this Agreement.

3.2 Duties of the MANAGER

The MANAGER agrees to:

Advise and consult with TALENT at all reasonable times.

Make no binding agreements on behalf of TALENT without obtaining TALENT's prior consent.

Provide advice on all contract and business details related to TALENT's services and employment.

4. Compensation

4.1 Manager's Commission

In consideration for the services provided by the MANAGER, GODZY MEDIA CONSULT shall be entitled to receive a commission equal to 30% of the compensation received by TALENT for every transaction entered into during the term of this Agreement.

4.2 Model's Responsibilities

TALENT shall provide professional photographs and an expression video to clients as required by the MANAGER. Further details will be explained by the MANAGER.

5. Confidentiality and Non-Competition

5.1 Confidentiality

Both parties agree to keep confidential any sensitive information or trade secrets disclosed during the course of this Agreement.

5.2 Non-Competition

TALENT agrees not to work with clients introduced by GodzyCasting without their knowledge and consent. Failure to abide by this provision may result in legal actions taken by GodzyCasting.

6. Term and Termination

6.1 Term

This Agreement shall commence on the effective date specified herein and shall continue until terminated as provided below.

6.2 Termination

This Agreement may be terminated by either party upon written notice to the other party if the other party breaches any material term or condition of this Agreement.

7. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of Ghana.

8. Entire Agreement

This Agreement constitutes the entire understanding between the parties with respect to its subject matter and supersedes all prior agreements, understandings, negotiations, and discussions, whether oral or written.
